


20,000 Gulf Troops At Risk

A mid a growing controversy, the Department of Defense (DoD) has announced it is notifying 20,800 U.S. Gulf War troops they may have been exposed to low levels of chemical weapons in the destruction of an Iraqi ammunition dump. And to help speed the notification process, the military has teamed up with the VA and veterans' service organizations to help find soldiers who may have been near Kamisiyah,

Iraq, during the period March 4-15, 1991.

The Kamisiyah munitions complex, also known as Tal al-Lahm, is approximately 15 miles southeast of An Nasiriyah in southern Iraq.

This massive notification effort has two purposes: to find out more about the health effects of suspected low-level exposure to nerve gas and to reconstruct events relating to the destruction by U.S. troops of the ammunition dump in southern Iraq at the end of the Persian Gulf War.

According to recent DoD estimates, 20,800 American soldiers were within 30 miles of the sprawling ammunition storage site at Kamisiyah when U.S. forces began demolition in March 1991. When evidence surfaced five years later that chemical weapons may have been among the munitions destroyed on March 4 and 10, 1991, it triggered an intensified effort on the part of the DoD to reconstruct the events at that time.

In addition, the DoD is investigating the possibility of a detonation at the Kamisiyah complex on March 12, 1991. However, offi-

cials say, it is not known if such a demolition occurred or if chemical munitions were involved.

U.S. officials apparently knew soon after the March 1991 detonation that the deadly nerve agents sarin and cyclosarin were stored at Kamisiyah. That discovery was made only after a United Nations team drilled into a rocket, releasing some of the nerve gas.

The DoD has repeatedly stressed that there is no evidence that any Americans had suffered acute exposure to nerve gas, either in a blast cloud from rockets or artillery shells destroyed at Kamisiyah or from other sources.

DAV Appeals Officer Named to Persian Gulf Illness Panel

VA Secretary Jesse Brown has appointed DAV National Appeals Officer Jeffrey C. Hall to serve on an expert panel investigating illnesses among Persian Gulf War veterans.

Issues being explored by the VA's Persian Gulf Expert Scientific Committee include findings that Persian Gulf War veterans have more health

problems than other veterans and whether Iraqi chemical weapons and other chemical agents are to blame for many of their ailments.

Mr. Hall's appointment offers the committee added perspective on issues related to Persian Gulf illnesses.

"As a Persian Gulf War veteran myself, I share a great many of the same concerns among these men and women who have fallen ill for unexplained reasons since their return home from the Persian Gulf," said the combat-disabled Army veteran.

Issues such as undiagnosed illnesses, whether they are caused by depleted uranium, diseases endemic to Southwest Asia, vaccinations, anti-nerve

agent pills and inoculations, as well as environmental hazards, continue to be among the DAV's highest priorities.

As a DAV National Appeals Officer, Mr. Hall's experience representing Persian Gulf War veterans with their claims for service-connected disabilities also (Continued on page 28)


will provide the panel with some insight into the adjudication and appeals processes.

"The DAV's membership has adopted resolutions supporting priority medical care and expeditious handling of Persian Gulf War claims by the VA and payment of fair and just compensation for their service-connected disabilities," noted National Service Director Kenneth D. Wolfe.

"We strongly maintain the VA has the responsibility to ensure these veterans are compensated for their illnesses without imposing a time limit," Mr. Wolfe said. "The need for an open presumptive period has now been heightened by the recent acknowledgment by the Department of Defense (DoD) that U.S. troops were likely exposed to chemical warfare agents.

"It is clear to the DAV that the issues involving health care and compensation will never be resolved without the full disclosure and cooperation by all government agencies concerned," said Mr. Wolfe. "We strongly encourage continued efforts by the medical and scientific communities in cooperation with the DoD, the Central Intelligence Agency, and the VA to provide a full and complete accounting of the possible exposure to chemical warfare agents and environmental hazards American forces faced in Southwest Asia."

ons in the Persian Gulf may shed some light on what many chronically ill Persian Gulf veterans have thought all along," said Mr. Gorman. "The DAV hopes that, finally, these veterans can begin to find the answers to what has been making them sick and they can get the proper medical care and other benefits they need and deserve."

The announcement in October 1996 that 20,800 U.S. Gulf War troops may have been exposed to chemical weapons greatly expands the search for possible victims from sarin and cyclosarin released from the Kamisiyah munitions dump. (The Defense Department has identified several military units that were within 30 miles of the munitions storage site when it was blown up in March 1991. See next column.)

Last June the DoD began notifying 150 soldiers with the Army's 37th Engineer Battalion who blew up rockets and shells at Kamisiyah. In September that figure was expanded to 5,000 troops who were within 15 miles of the site.

DAV National Commander Gregory C. Reed cited the Defense Department's belated acknowledgment that American forces were at risk of chemical weapons exposure and called for immediate congressional hearings into the matter. The DAV also strongly urged the VA to extend the eligibility period for service-connected disability compensation for Persian Gulf veterans suffering from undiagnosed illnesses. (See the September/October 1996 and November/December 1996 issues of DAV Magazine.)

VA officials told the DAV there still is no known link between chemical weapons and the undiagnosed Gulf War illnesses, so the two-year presumptive period for service-connected disability benefits remains in effect. However, the VA will continue providing priority health care to those veterans.

"From the outset, the DAV has strongly opposed a two-year limit until science finds out why these men and women are sick. Now, more than ever, we believe the presumptive period should remain open-ended," said Mr. Gorman

"Conflicting information from the Defense Department about the presence of chemical weapons and the escalating number of possible exposures-almost on a weekly basis-has left a huge credibility gap," said Mr. Gorman. "And the men and women

who did their patriotic duty only to have their health ruined by serious illnesses that medical and scientific experts can't account for are suffering because of it."

Since June the figure on possible exposures from the destruction of Kamisiyah has grown steadily, and officials have told the DAV that the DoD will be looking for indications that chemical weapons were stored at other Iraqi munitions dumps.

Of immediate concern, the DoD said, is to find out as much as possible about what happened at Kamisiyah and determine if health problems among soldiers in the area could be linked to low-level exposure to nerve gas. Funding for DoD research initiatives associated with this effort has more than doubled from \$12 million to \$27 million.

The Central Intelligence Agency (CIA) and the Defense Department have been working on a computer model using weather patterns and other factors to estimate the drift of the chemical cloud from Kamisiyah that could greatly expand possible exposures. Information on the dispersion of chemical warfare agents was to have been released in October 1996, but was delayed until a panel of outside experts, including meteorologists and other scientists, could verify its accuracy.

According to some informed estimates, more than 100,000 Americans may have been exposed to chemical warfare agents.

In the meantime, the VA and the DoD have joined forces to track down more than 20,000 men and women who, based on the military's "best guess," could have been exposed to nerve gas from Kamisiyah.
